

## **CONSENT TO CONDUCT TRANSACTIONS ELECTRONICALLY AND TO RECEIVE ELECTRONIC DISCLOSURES AND NOTICES**

On June 30, 2000, Congress enacted the Electronic Signatures in Global and National Commerce Act ("E-Sign Act") to ensure the legality of electronic contracts. Before obtaining products or services electronically through *Peoples Bank*, you must consent to this agreement. Your consent covers all of your transactions relating to the products or services that you agree to obtain electronically. Please read this E-Sign Customer Agreement carefully and keep a copy for your records.

The undersigned agrees to the following provisions regarding opening a Peoples Cash Solutions account with *Peoples Bank*:

In order to speed up the deposit account application process, with your consent, we will provide you with the following information electronically, rather than by postal mail or in person:

- All related account disclosures required by applicable federal and state law for the deposit product you have selected;
- Instructions for signing and returning a Signature Card and Identifying information (if applicable); and
- Information and instructions about any additional services that you select during the application process.

If you do not want to receive the legal disclosures, agreements, Signatures card, and the instructions electronically, you should exit this area of our web site. If you do not consent to receiving an electronic copy of these related documents, we will not be able to open the deposit account via our website. You must have software which permits you to receive and access Portable Document Format or "PDF" files, such as Adobe Acrobat Reader® version 8 or higher (available for downloading at <http://get.adobe.com/reader>).
